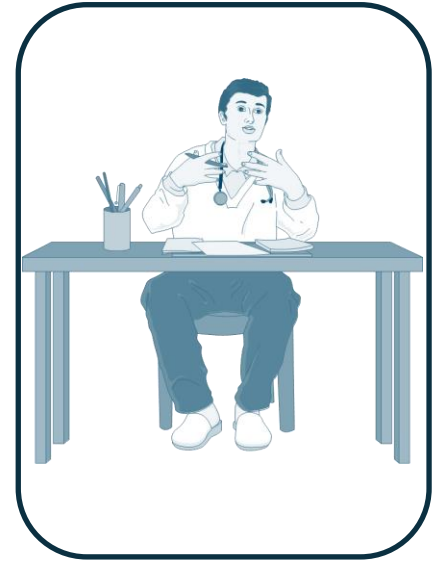
Blood collection

Data Analysis and Report



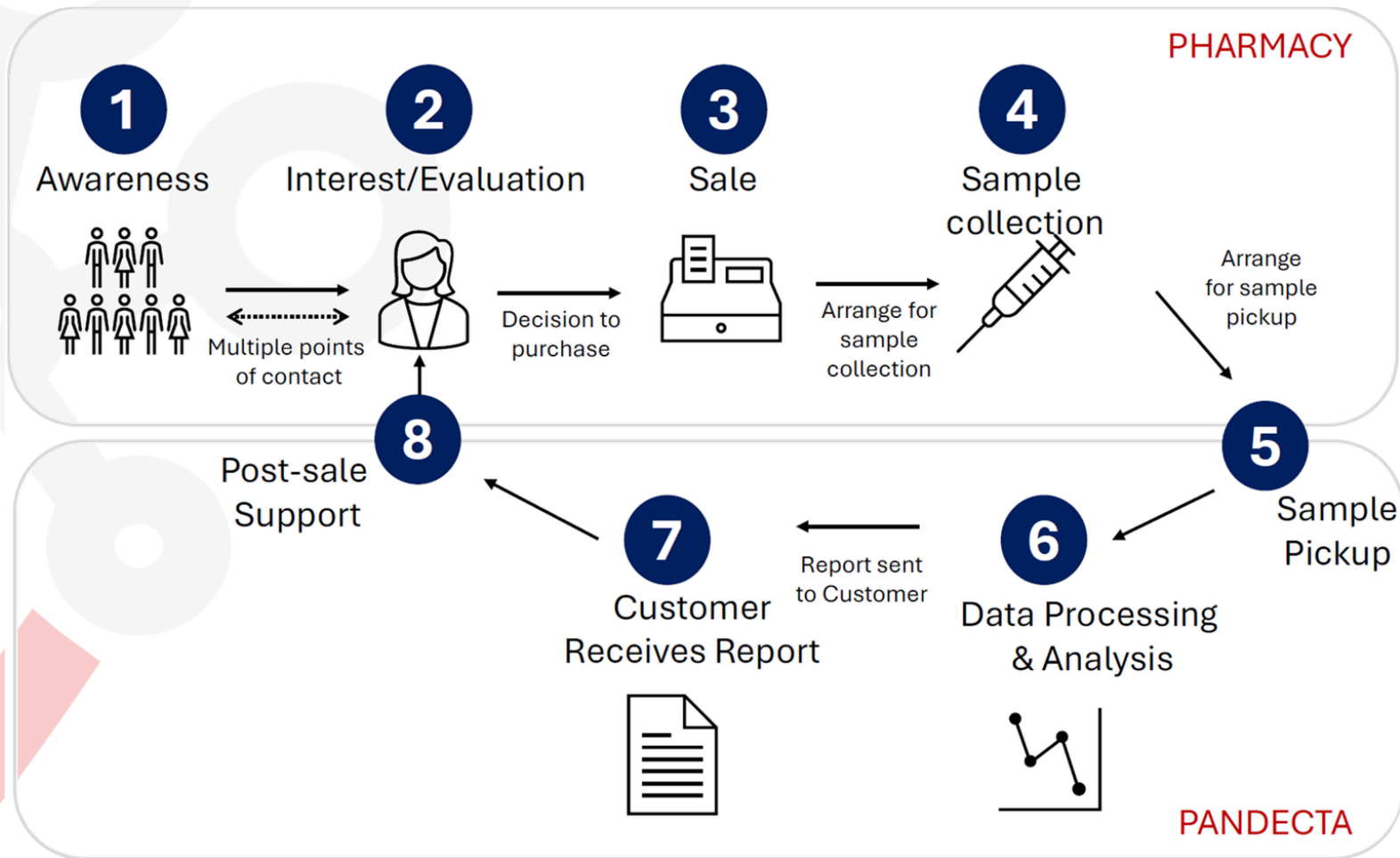


Overview of Process

2. Initial Contact

- Potential client expresses an interest to the pharmacist
- Pharmacist explains and answers the questions explained in the training materials and FAQ
- There may be more than one initial contact before the customer decides to buy
- **Documents Provided:** Training Materials; FAQ



3. Sale

- Customer purchases the product
- Blood collection appointment made
- Customer familiarized with Terms of Service and Privacy Policy
- Offered to complete a Survey
- **Documents provided:** SOP; Terms of Service, Privacy Policy, Survey



4. & 5. Blood Sample Collection and Pickup

- Blood collection date is set ahead of time
- Pandecta Representative is notified of the collection date
- 1 ml of blood is collected from patient (EDTA – purple tubes)
- Blood is put in the fridge
- Pandecta representative is contacted for pick up following successful collection
- Within 24 hours samples is picked up by Pandecta's courier
- **Documents provided:** SOP



6. Data Generation and Analysis

- Blood samples are processed and analyzed at Pandecta facilities
- Quantitative data for thousands of circulating proteins is generated
- Data analysis to identify proteins significantly different in your profile



7. Report Generation

- AI – assisted comprehensive report is generated and a personalized health risk assessment is provided to the customer
- Report detailing personalized health risk assessment is provided to the customer
- Risk assessment is based on: currently approved clinical markers, markers currently in clinical research that have been highly validated, and combination of markers that have been shown to influence disease pathways
- Personalized recommendations for follow up are included such as contacting healthcare providers and/or recommendations for lifestyle changes



8. Post sale support

- Pharmacist helps in the interpretation of the patient report (with reference to FAQ)
- Pharmacist may recommend a Healthcare Professional who may consult with the patient
- Pharmacist may consult the patient on lifestyle changes and supplemental nutrients options
